- 3 The Parent / Guardian is responsible for the applicant and the applicants' adherence to this document if the applicant is under the age of 18 years
- 4 SARRC will not give out your personal details to any third party without your permission with the exception to other official organisations as determined by SARRC including but not limited to First In Sport First Aid and Event Strategies (timing)
- 5 I acknowledge and consent to photographs and electronic images being taken of me during my participation in SARRC events by an official or organisation working with SARRC. I acknowledge and agree that such photographs and electronic images are owned by SARRC and that SARRC may use the photographs for promotional or other

purposes without my further consent being necessary. Further, I consent to SARRC using my name, image, likeness and also my performance in any SARRC Event, at any time, by any form of media, to promote the event and SARRC. SARRC is not responsible for photographs and electronic images taken by persons who are not an official representative of SARRC.
